# Club & Championship Rules 2020

# Club Rules Governance and Membership

1. "The Club" shall be the Northern Phoenix Trials Car Club Limited (NPTCC) and shall be governed and managed in accordance with the company's articles of association ("the articles") and these Club and Championship Rules ("the rules")



#### 2. Fully Paid-up Members:

All fully paid-up members of the Club are full members of NPTCC and are entitled to attend and vote at
its annual general meetings (AGM) and general meetings and may exercise all the rights of members
prescribed in the articles.

#### **Event Day Members**

- Single event day memberships shall be made available by the Club to enable non-members to compete
  in Club events. Day membership shall not confer full membership rights.
- 3. The Club's directors collectively shall comprise the Club's management committee ("the committee").
- 4. The rules may be altered by the committee or by the members at a general meeting. The articles may only be altered by a special resolution of the members passed by a 75% majority at a general meeting.
- 5. In the event of any inconsistency between the rules and the articles, the articles will take precedence.

#### **Liability of Members**

- 6. NPTCC is a company limited by guarantee having no share capital. Each member, in tendering their membership subscription, undertakes that if the company is wound up while he/she is a member (or within one year after he/she ceases to be a member), he/she will contribute up to a maximum of £1 to the assets of the company, to be applied towards:
  - payment of the company's debts and liabilities contracted before he/she ceases to be a member;
  - payment of the costs, charges and expenses of winding up; and
  - adjustment of the rights of the contributories among themselves.

#### **Application for Membership**

- 7. Any person aged 14 years or over, who wishes to become a member must sign, and lodge with the Club, a completed membership application form, accompanied by the annual membership subscription fee. Applicants under18 years of age must also include with their application the written consent of a parent or legal guardian.
- 8. The committee may, at its absolute discretion, refuse to admit any person to membership.
- 9. Applications for full membership will normally be considered by the Membership Secretary upon receipt of the application (and accompanying fee). Applicants will be notified of the decision on the application and, if the decision was to refuse admission, the Club will return the applicant's subscription fee.
- 10. To assist the efficient administration of the Club, full members are required to provide the Club with details of an electronic means of communication which can be used for all the official communications, notices and documents required by the articles, the rules or by prevailing company law, as well as for general administrative purposes. The preferred method is a personal email address, or failing that, an email address of a consenting third party. Should neither of these alternatives be available, members are required to provide a personal mobile or other telephone number which is able to receive text messages so they can be alerted to any official communications published on the Club's website. The onus is on each member to notify the Club of such details and to update them should they change.

#### **Membership Subscription**

- 11. Full members shall be required to pay an annual subscription and day members a day subscription. The amount of the subscriptions shall be determined by the committee or the members at the AGM.
- 12. Annual membership subscriptions shall be payable on or before 31 January in each year.
- 13. If the annual membership subscription payable by any member remains outstanding more than 12 weeks after the date on which it fell due, he/she shall automatically cease to be a member.

14. A person who ceases (for whatever reason) to be a member shall not be entitled to any refund of the membership subscription.

#### **Observance and Interpretation**

- 15. It is a fundamental condition of membership that every member (full and day) binds him/herself to:
  - recognise and accept the risks inherent in motorsport and to take personal responsibility for their own safety and the safety of other participants at Club events;
  - abide by the Club's prevailing articles, rules, policies and guidelines; and,
  - accept as final and binding the decision of the Club's committee in relation to any issues or disputes regarding interpretation of the rules and/or articles.
- 16. Members found to be in serious or repeated breach of the rules will be liable to expulsion from membership by the committee.

#### **Events**

- 17. All sporting trial events ("events") organised by the Club shall be held under the Motor Sports Association's (MSUK) rules and requirements. No events shall take place unless there is a valid MSUK permit for the event or the MSUK has issued an exemption certificate in respect of it.
- 18. All members participating in any capacity in an event shall familiarise themselves with the MSUK's national sporting code, common regulations, and its regulations relating to sporting trials, (all of which can be found in the MSUK's Year Book on the MSUK website: <a href="www.msuk.org">www.msuk.org</a> ), together the Club's supplementary regulations for the event and its Child Protection Policy (which can be found on its website (<a href="www.nptcc.org.uk">www.nptcc.org.uk</a>) and shall be bound by them all.
- 19. The nominated clerk of the course for each event is responsible for ensuring event safety and any instructions issued by him/her to other event participants are to be complied with.
- 20. Only active event competitors with more than two years' experience who are adequately trained or otherwise competent are permitted to undertake the roles of clerks of the course or scrutineers. Prospective new clerks and scrutineers must in addition have acted as assistant clerks or scrutineers for a minimum of three previous events.

## **Championship Rules**

#### **Title and Jurisdiction**

21. An annual championship ("the Championship") is organised and administered by Northern Phoenix Trials Car Club Ltd in accordance with the General Championship Prescriptions of the MSUK and these Championship rules.

#### **Officials**

- 22. Championship Secretary and Scorer: Rob Baxter.
- 23. Eligibility Scrutineer: Martin Grimwood/Bryan Walker.
- 24. Championship Stewards: NPTCC Committee.

#### **Competitor Eligibility**

- 25. All competitors must be members of the Club.(or invited clubs)
- 26. Competitors must "Help" during the season (see below).
- 27. Registration will be by the issue of a club membership card.

#### **Championship Calendar**

28. The Calendar of Events qualifying for the Championship will follow the calendar year.

#### **Championship Classes**

#### **Drivers**

- 29. In each Championship event, there will be three ability classes, A, B and C, together with an optional live axle class. The aim is to achieve four competitive classes: the three ability classes comprising drivers exhibiting advanced, intermediate and novice abilities respectively, and the fourth live axle class, which any eligible driver competing in a live axle car may opt to compete in.
- 30. Drivers will be classified A, B, or C before the first event of the year based on their average score/finishing positions in the preceding year's Club Championship events.
- 31. Drivers new to the sport will be automatically placed in Class C. Any driver joining the Club who competed the preceding year in any other sporting trial championship will be assigned to the class deemed most appropriate by the committee.
- 32. Drivers will remain in the same ability class for the whole of the Championship year, unless re-classified by the committee, who retain the right to re-classify any driver at any point during the Championship year.

- 33. Class A will consist of drivers whose average Championship event scores fall within the highest score band, to be determined by the committee after the last trial of the season.
- 34. Class B will consist of drivers whose average Championship event scores fall within the next highest score band, to be determined by the committee after the last trial of the season.
- 35. Class C will consist of drivers not qualified in either the A or B classes as defined above.
- 36. Drivers may appeal to the committee regarding their classification within 21 days of its publication.
- 37. A driver may be moved up one or two ability classes between consecutive Championship years, but can only be moved down one class, on the basis of the point score banding referred to in rules 34-36 above. Such reclassification is dependent upon a minimum of four Championship trials being completed. Relegations into Class C will not be made where the committee judge that it would lead to novice drivers being unfairly disadvantaged within their competitive group.

#### **Passengers**

38. Passengers inherit the class of the driver.

#### **Championship Scoring**

- 39. In each Championship event 30 Championship points will be awarded to the winner, 28 to second, and 27 to third and so on. Each day of multi-day events will count as a separate event and Championship points will be awarded accordingly for each day. In addition, the committee may determine, in advance of an event, also to award Championship points based on the combined results of multi-day events, with the overall winner being awarded 30 points, 28 to second, 27 to third and so on.
- 40. No Championship points will be awarded for officiating.
- 41. To facilitate a sporting and gentlemanly practice endorsed by the MSUK at Club-level events, all entrants, in submitting a Clubman's entry for and participating in any NPTCC Championship event, shall be deemed to have given written notice of a change of car, in accordance with Regulation D25.1.12, should they need to complete the event by double driving a fellow competitor's car, due to mechanical failure or some other defect affecting the car nominated on their entry form. Any such change of car at an event shall require the consent of the Clerk of the Course (such consent not to be unreasonably withheld). Provided that details of the car change are notified to the Secretary of the Meeting at the conclusion of the event, the car-change entrant's score for the entire event, plus an additional 12 penalty points, shall be valid and included in the event results. For the avoidance of doubt, the use of spare cars will not be permitted.

#### **Final Championship Positions**

- 42. Final Championship positions in each class will be determined on the basis of the aggregate of Championship points scored in each competitor's best counting scores. Counting scores are 75% 0f the events organised by the club rounded up to the next whole number. E.g. 16 events = 16 x 0.75 = 12 counting rounds 15 events = 16 x 0.75 = 11.25 rounds to 12 14 events = 14 x 0.75 = 10.5 rounds to 11 etc.
- 43. Ties will be decided by the current MSUK championship system.
- 44. Championship competitors (Drivers and Passengers)will only be included in the scores if they have helped (or arranged to do so) during the season.
- 45. Help is being either a Clerk of Course or assistant Clerk of Course or other duty agreed by the committee.

#### General

- 48. There is a three second allowance for a competitor's car to regain forward motion, with no rearward motion. Marshal to count "and 1 and 2 and 3".
- 49. The three second rule does not apply should a competitor stall the engine except as provided for by rule 50.
- 50. If a competitor stalls the engine on a downhill section and the car continues forward motion, a restart is permitted without a penalty.
- 51. If a car ceases forward motion and neither rear wheel is rotating, the three second rule shall not apply and the driver shall be deemed to have stopped.

- 52. The only circumstances in which a competitor maybe considered for a re-run of a section are:
  - a. where another vehicle, animal or person is judged to have impeded progress through the section and where to have continued would have been potentially dangerous; or,
  - b. in any circumstances permitted in the Motor Sports Association current year book (the MSUK "Blue Book").
- 53. The only permitted tyres to be used in any event will be as specified in the event's Supplementary Regulations.
- 54. Competitors found competing in Club events with tyre pressures below those specified for the event will incur a 12-point penalty per offence.
- 55. Passengers are permitted to compete in a maximum of two cars as long as both are running within three cars of each other.
- 56. Cars must have a registered "Sharp" diff seal fitted to compete in an event. If a car does not have a red "Sharp" seal then a blue seal will be fitted before the start of the event and will be valid for 3 trials and then must be tested. If the diff passes the test then all results will stand, if not the competitors will be excluded for events to that date. the committee retain the right to extend the 3 trial period if it has not been possible for Richard to organise the test.
- 57. Drivers must produce their car's logbook at all events as specified in the event's Supplementary Regulations.

## **Annual and Event-Day Awards**

#### **Annual Awards**

58. The Club will present Annual Awards at its annual Presentation Dinner as follows:

#### **Event Awards:**

• Overall Event Winners (driver and passenger team) of each Championship event staged by the Club.

#### Club Awards:

- Trial of the Year awarded to Clerk of the Course for what is judged to be the best trial of the season.
- Best Rookie awarded to the Rookie highest placed in the final Championship table. (Drivers are classed as rookies until they have completed two full seasons from the date of their first Class C trial.)
- Best Club Official awarded to the Club Official voted as such by the Club Members.

#### **Championship Awards**

#### **Drivers:**

- 1<sup>st</sup> overall Class A
- 1<sup>st</sup> overall Class B
- 1<sup>st</sup> overall Class C
- 1<sup>st</sup> overall Live Axle Class
- **Highest Number of Cleans** (counted from all the trials driven in the season not just the counting scores).

#### **Passengers**

- 1<sup>st</sup> overall Class A
- 1st overall Class B
- 1st overall Class C

#### **Event-Day Awards**

- 59. Event-day awards will be presented at each Championship event staged by the Club as follows:
  - Winning Driver & Passenger Team of each Competitive Class subject to a minimum of three entries in the class.
