NPTCC Privacy Notice

Northern Phoenix Trials Car Club Limited (NPTCC) respects your privacy and we will only use your information in the way described here. When using your information we aim to be fair and transparent, and to follow our obligations under UK data protection laws. Your information is kept secure and used solely for administering club membership, activities and competitions.

NPTCC is the data controller for the purpose of GDPR and the Data Protection Act 2018. Our registered address is 18 Cheltenham Parade, Harrogate, North Yorkshire, HG1 1DB. Our club contact for privacy and data is the Club Chairman, and the contact details are chairman@nptcc.org.uk.



The information we hold

A general database is held by the Club Chairman, the website administrator has a record of members' and names and email addresses and the membership secretary also holds a list of members' names. Information is collected when a membership application or a competition event entry form is completed. This includes: Surname and Forename, Address, Home and Mobile Phone number and email address. We also record the name of an emergency contact. When you give us information about another person, such as a child, parent, guardian, or emergency contact you should let that person know that you have given us the information. If you are under 18 years old, we will also ask for information from a parent or guardian. Finally, we record the date of becoming a member and your type of competition car if you are an entrant.

Using your information

We use your information to administer your membership of the NPTCC, advise you of events and Club activities and to give you access to the weblog on the NPTCC website. We will not sell your information to another organisation. To support your relationship with the NPTCC we may keep your information up to three years after you cease to be a member unless you ask us to delete it.

Sharing your information

We may share your information with the Motor Sports Association as required by its General Regulations for governing motor sport, with other MSA Registered Clubs, with medical personnel, or any other person if we have to comply with a legal obligation.

Our website

The NPTCC website, www.nptcc.org.uk has SSL (Secure Sockets Layer) enabled to increase security by encrypting the data transferred between the website and its visitors. When you visit the website, we store cookies on your computer, they are used in an aggregate form for statistical purposes. This forms an overview of how many people visit the site. It is not possible to identify individuals from cookies but if you do not want cookies to be stored on your computer you can disable cookies in your web browser. Security for your information

Your information is held securely by us. We have taken all reasonable steps, and have in place appropriate security measures, to protect your information.

Your rights

The GDPR includes the right to be informed and the right to access, rectification of errors or erasure. However, should you ask us to stop using your information, and to delete it, we will not be able to continue our contract with you as a member.
